## Travelzoo Reports Fourth Quarter, Year End 2001 Financial Results

**MOUNTAIN VIEW, Calif., April 18, 2002** -- Travelzoo Inc. (<http://www.travelzoo.com>), a provider of online marketing solutions for the travel industry, today announced financial results for the fourth quarter and the fiscal year ended December 31, 2001.

Total revenue for the fourth quarter of 2001 was \$1.7 million, an increase of 47.5% from \$1.2 million reported in the same period of 2000, and an increase of 9.4% from \$1.6 million reported for the quarter ended September 30, 2001.

For the twelve months of 2001, total revenue was \$6.1 million, a 55.7% increase compared to \$3.9 million for the twelve months of 2000.

Reported net income for the quarter ended December 31, 2001 was \$15,391. Reported net income for the year ended December 31, 2001 was \$363,735. Pro forma net income per share for the year ended December 31, 2001 was \$0.02 per share.

Reported net income includes the combined results of Travelzoo.com Corporation and Travelzoo Inc. as explained in the complete set of audited financial statements. Travelzoo Inc. advises investors to review the complete audited financial statements which have been filed with the Securities and Exchange Commission on form 10-K. On March 15, 2002, the shareholders of Travelzoo.com Corporation approved the merger into a newly formed Delaware subsidiary, Travelzoo Inc. The closing of the merger is pending. The pro forma per share financial information is presented to give effect to the merger between Travelzoo.com Corporation and Travelzoo Inc. The pro forma presentation assumes all shareholders elect to exchange their shares.
